Please be advised that on or about Monday, March 14, 2022, weather permitting, work will begin on drainage improvements on Newman Street between 17<sup>th</sup> Avenue and New Bedford Road as part of the above referenced project. Work will include the repair/replacement of storm sewer inlets and piping as well as the installation of new inlets and piping along Newman Street.

Our office will have a representative on-site during construction to monitor the work of the Contractor, Fernandes Construction (732-266-4816). We will attempt to coordinate any work to be done in your area in order to minimize possible inconveniences.

In order to facilitate the work, we respectfully request that when possible no cars be parked on the street in the area the work is being performed. We also request that should you need access to your car, that you do not park in your driveway. The contractor will attempt to maintain at least one (1) lane of traffic during the day and two (2) lanes at night. However, at certain times the road may have to be closed to traffic except to those residents who live within the project limits. During this period, detours will be posted. It is expected that no work will be done on weekends or major holidays unless absolutely necessary.

On behalf of the Mayor and Borough Council, we would like to thank you for your anticipated cooperation in this matter and apologize in advance for any inconveniences that may be caused during construction.
