



WHEREAS, Claude De Simone, owner of 17 Ripley Lane, Lake Como, NJ, also known as Block - 19, Lot – 6.01, applied for Tree Removal Permit #17-09 to remove a total of sixteen (16)) trees, two (2) of which are dead or diseased, for the purpose of building a new home; and

WHEREAS, in addition to the \$50.00 Application Fee, the owner posted the required \$2,800.00 Escrow Fee (\$200.00 per tree) which was deposited into the Tree Replacement Fund and which is refundable upon satisfactory planting of new saplings; and

WHEREAS, the application stated that fourteen (14) trees would be removed, not including two (2) dead/diseased trees, and fourteen (14) new replacement trees would be planted; and

WHEREAS, upon recent inspection of the property by Zoning Officer Mark Fessler, it was determined that in addition to the fourteen (14) trees approved for removal, seven (7) additional trees were removed or damaged or killed during construction. These additional removed trees require nine (9) more additional replacement trees equaling a total of twenty-three (23) replacement trees to be planted; and

WHEREAS, fourteen (14) new trees were required to be planted, a total of twenty-one (21) acceptable replacement trees were planted making the planting of two (2) more trees necessary or \$200.00 per tree to be paid into the Tree Replacement Fund.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Lake Como that \$2,400.00 of the Escrow Fee posted with Check # 2078 be refunded to Mr. De Simone and the balance of \$400.00 shall remain in the Tree Replacement Fund until such time as two (2) additional replacement trees are planted and deemed acceptable.
