Please be advised that on or about Tuesday, July 7, 2020, weather permitting, roadway reconstruction work will commence North Boulevard between Main Street and Ripley Lane as part of the above referenced project.

Our office will have a representative on-site during construction to monitor the work of the Contractor, Jads Construction (732-254-9462). We will attempt to coordinate any work to be done in your area in order to minimize possible inconveniences.

In order to facilitate the work, we respectfully request that cars be kept out of your driveways should you need to use them and that no cars be parked on the street while the work is being performed. The contractor will attempt to maintain at least one (1) lane of traffic during the day and two (2) lanes at night. However, at certain times the road may have to be closed to traffic except to those residents who live within the project limits. During this period, detours will be posted. It is expected that no work will be done on weekends or major holidays unless absolutely necessary..
