1. Fees **\$120.00** For One Day License For Each Vendor.  
Veterans Fees \$10.00 with Proof of Veterans Status  
**FEES ARE NON-REFUNDABLE**
2. **TWO (2) 2x2 CURRENT** Passport Photos.  
**Photos Must Be Current & Passport Photos Or Application Will Be Returned & Your Spot Forfeited Until All Correct Items Are Submitted.**
3. State Of New Jersey Tax Identification.
4. Photo Copy of **Valid** Drivers License Or Social Security Card If You Do Not Have A Drivers License. **Please Send Drivers License On A Full Size Sheet Of Paper.**
5. Food Carts Must Have A Monmouth County Board Of Health Certificate & Fill Out And Send The Temporary Food License Application To The County Directly. Any Food Cart Cooking With An Open Flame, Must Fill Out The Open Flame Permit Application & Submit \$42.00 Fee Along With Application Fee.
6. No Mercantile Licenses Shall Be Issued To Any Vendor Unless They Agree To **Not Sell Silly String, Stink Bombs Aka Poppers** For The Day Of The Parade. Any Vendor Caught Selling Any of the Above **Will Be Removed** From The Parade Route
7. **All Applications Must Be Typed Or Neatly Hand Printed. Any Applications That Are Illegible Will Not Be Processed and Fees Will Not Be Returned.**
8. Lake Como Will Supply Shirts & Badges That All Vendors Must Wear While Vending On The St. Patrick's Day Parade in Lake Como. It Will Be Your Responsibility To Pick Them Up The Day Of The Parade At Police Headquarters at 601 Main Street, Belmar, NJ 07719.
9. Vendors Not Pushing A Cart Must Obtain Permission From A Property Owner To Set Up Their Stands. No Vendor Is Permitted To Set Up Stands On Any Public Street.
