TO EXECUTE THE FY2021-2023 AGREEMENT WITH MONMOUTH COUNTY FOR

COOPERATIVE PARTICIPATION IN THE COMMUNITY DEVELOPMENT

PROGRAM PURSUANT TO THE INTERLOCAL SERVICES ACT

WHEREAS, certain Federal funds are potentially available to Monmouth County under Title

I of the Housing and Community Development Act of 1974, as amended, commonly known as the

Community Development Block Grant Program; and

WHEREAS, it is necessary to establish a legal basis for the County and its people to benefit

from this program; and

WHEREAS, an Agreement has been proposed under which the and the County of

Monmouth in cooperation with other municipalities will establish an Interlocal Services Program

pursuant to N.J.S.A. 40:8B-1; and

WHEREAS, it is in the best interest of the Borough of Lake Como to enter into such an

agreement.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Governing Body of the

Borough of Lake Como, that the agreement entitled "AGREEMENT BETWEEN THE COUNTY

OF MONMOUTH AND CERTAIN MUNICIPALITIES LOCATED HEREIN FOR THE

ESTABLISHMENT OF A COOPERATIVE MEANS OF CONDUCTING CERTAIN

COMMUNITY DEVELOPMENT ACTIVITIES", a copy of which is attached hereto, be executed by

the Mayor and Municipal Clerk in accordance with the provisions of law; and

BE IT FURTHER ORDAINED that this resolution shall take effect immediately upon its

enactment.

RESOLUTION NO. 2020-81 BOROUGH OF LAKE COMO AUTHORIZE TAX COLLECTOR TO ISSUE ESTIMATED TAX BILLS

WHEREAS, the Borough of Lake Como's Municipal Budget has not been adopted, and the State of New Jersey will not be adopting their budget until September 2020, the County of Monmouth is unable to certify the Borough's current 2020 tax rate; and

WHEREAS, the Tax Collector will be unable to mail the Borough's 2020 tax bills on a timely basis; and

WHEREAS, the Lake Como Tax Collector in consultation with the Lake Como Chief Financial Officer has computed an estimated tax levy in accordance with N.J.S.A. 54:4-66.3, and they have both signed a certification summarizing the tax levies for the previous year, the tax rates and the estimated tax levies for the 2020 calendar year;

NOW, THEREFORE, BE IT RESOLVED, by the Governing Body of the Borough of Lake Como, in the County of Monmouth and State of New Jersey on this 21st day of April as follows:

The Borough of Lake Como Tax Collector is hereby authorized and directed to prepare and issue estimated tax bills for the Borough for the third installment of 2020 taxes. The Tax Collector shall proceed and take such actions as are permitted and required by P.L. 1994, c.72 (N.J.S.A. 54:4-66.2 and 54:4-66.3).

The estimated calendar year tax levy for 2020 is hereby calculated at \$6,516,000.00. The maximum amount that the Borough will utilize in the preparation of the 2020 estimated tax bills is less than 105% of the 2019 calendar year tax levy is hereby notifying the State of New Jersey of the attached certified rate.

In accordance with New Jersey Statutes, the third installment of 2020 taxes shall not be subject to interest until the later of August 10th or the twenty-fifth calendar day after the date the estimated tax bills were mailed. The estimated tax bills shall contain a notice specifying the date on which interest may begin to accrue.
