Thank you for your interest in being a vendor at the 22nd Annual Lake Como Day, which will be accompanied this year by fireworks. The event will be held on Saturday September 30, 2017 with a rain date of Sunday October 1, 2017. To make this event run smoothly please read the following rules and requirements.

- 1- All vendors must fill out the application that is attached in it's **entirety**
- 2- Any vendor selling food has to fill out an additional Board of Health Temporary Food License application and send it directly to the **Monmouth County Board of Health.**
- 3- Any vendor using propane, fryers, grills, etc. are **REQUIRED** to fill out an Open Flame Permit Application, which will be an additional \$42.00 fee.
- 4- Vendors selling food must set up 2 hours prior to the event to give the Health Inspector ample time to inspect the set up. Vendors requiring the Open Flame Permit are also going to be inspected by the Lake Como Fire Official.
- 5- **No vendor will be allowed to sell any of the follow items:**
  1. silly string, party string, etc.
  2. poppers, stink bombs, etc.
  3. anything that may be hazardous to the wildlife at the lake.

**ANY VENDOR CAUGHT SELLING THESE ITEMS WILL IMMEDIATELY BE SHUT DOWN AND NOT PERMITTED TO ANY FUTURE LAKE COMO EVENTS.**

- 6- **ALL VENDORS MUST BRING THEIR OWN TENTS, TABLES, CHAIRS, POWER SOURCE AND LIGHTS IF NEEDED.**
