- Mayor Higgins reported that on tonight's agenda, there is a resolution authorizing engineering services for the potential sale of the water and sewer utilities. This has been an issue Since Superstorm and the Borough has invested greatly into their water system. After Sandy, New Jersey American Water gave the town a very low offer to buy the system, because of this, the Borough got loans to clean and line the pipes which has led to very high water bills. Mayor Higgins reported that the Borough has talked to SMMUA to purchase water from them but their pipes are not large enough to feed Lake Como so we are back to looking into selling the system. Because of this, the Borough needs to have the water system assessed with Engineering Services. Mayor Higgins reported that the Borough's Special Project Engineer CME Associated, if the resolution is passed, will be authorized tonight to begin that process. All other matters are in order.
