County residents may shred up to 100 pounds, which is equivalent to four office paper boxes or four large-sized trash bags. All papers will be shredded on location in the mobile trucks and the event will end once the mobile trucks are full or its scheduled end time. Large binder clips must be removed from documents; staples and paper clips can remain.

This program is hosted by the Monmouth County Board of County Commissioners and the participating municipalities: Allenhurst, Atlantic Highlands, Bradley Beach, Brielle, Colts Neck, Fair Haven, Freehold Twp., Hazlet, Long Branch, Marlboro, Matawan, Middletown, Millstone, Neptune Twp., Oceanport, and Shrewsbury Boro.

### STORMWATER PREVENTION

As we enter the mowing season, please help us to avoid grass clippings being leaf-blown into the gutter, practice mulching. They go into the storm sewers and eventually end up in our lakes and ocean. ### **CODE ENFORCEMENT**

### MANDATORY SALE/RENTAL INSPECTION

As per Borough Ordinance, you are required to obtain a Certificate of Inspection on all sales, all rentals, and any long-term rental unites that have not been inspected within the past three (3) years.

This pertains to anyone operating an Airbnb or VRBO rental. Those is violation face fines up to \$2,000.00.

### **OVERCROWDING**

Landlords who rent units to more persons than legally allowed will be issued a summons, BO 9-4.6. Any tenants who over occupy a dwelling after a Certificate of Inspection is issued will receive a summons for each person in the dwelling.

### **HOUSE NUMBERS**

It is imperative that house numbers and business addresses be clearly visible on each and every property in town. House numbers are very important in the day-to-day operation of the town, but in an emergency situation, it could mean the difference between life and death. House and business address numbers must be a minimum of three inches (3") in height.

### **DID YOU KNOW...**
